Personal leave days should also have been added. One (1) personal leave day for a first year employee, two (2) personal leave days for a second year employee, and three (3) personal leave days for employees in their third and subsequent years. ## HTA Dues Breakdown

Three organizations are supported with the dues each member pays. The American Federation of Teachers (AFT) is the national organization. The dues to AFT are \$228.36 for the 2016-2017 school year. The second portion of the dues, \$378.00, goes to the New York State United Teachers (NYSUT). The local portion of the dues, \$120.00, goes to the Hudson Teachers Association. The local dues are used to support social activities for members, charitable contributions to community groups that support the children in the Hudson City School District, and recognition of life events (births, weddings, illness and death) of the members. Total dues= \$726.36 for full time teachers for the year.
